

ORDINANCE NO. 4786

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ELLENSBURG, WASHINGTON, RELATING TO RATES AND FEES FOR PARKS AND RECREATION FACILITIES IN THE CITY OF ELLENSBURG; AMENDING SECTIONS 2.34.240, 2.35.040, 2.38.040, AND 2.38.050 OF THE ELLENSBURG CITY CODE.

WHEREAS, the City of Ellensburg ("City") wishes to update the fee categories to reflect the current rates at City parks, the Ellensburg Racquet & Recreation Center and the Kittitas Valley Memorial Pool & Fitness Center;

WHEREAS, the City wishes to include a new rate for use of City recreational facilities for those military veterans who have served our country;

NOW, THEREFORE, the City Council of the City of Ellensburg, Washington do hereby ordain as follows:

Section 1. Section 2.34.240 Fees and charges of the Ellensburg City Code, as last amended by Section 1 of Ordinance 4435, is hereby amended to read as follows:

D. Picnic Shelter Rental Rates and Parks Grounds Fees— Incremental Annual Fee Increases. Beginning January 1, 2008, the rates set forth for picnic shelter rentals and parks grounds fees shall automatically increase by five percent, and thereafter on the first day of January of each successive year said rates and fees shall automatically increase by five percent over the prior year's rates and fees; provided, however, any such increases shall be rounded to the nearest five cents. Section 4. Section 2.38.050 Incremental annual fee increases of the Ellensburg City Code, as last amended by Ordinance 4319, is hereby amended to read as follows:

2.38.050 Incremental annual fee increases.


~~On January 1, 2002, the rates and fees set forth in ECC 2.38.040 shall automatically increase by five percent, and thereafter on the first day of January of each successive year said rates and fees shall automatically increase by five percent over the prior year's rates and fees; provided, however, any such increases shall be rounded to the nearest \$0.05. The parks and recreation director shall annually publish the rates and fees for the Kittitas Valley Memorial Swimming Pool.~~

Section 5. Severability. If any portion of this ordinance is declared invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect the validity of the remaining portion(s) of this ordinance.


Section 6. Corrections. Upon the approval of the City Attorney, the City Clerk and the codifiers of this ordinance are authorized to make necessary corrections to this ordinance including, but not limited to, the correction of scrivener's/clerical errors, references, ordinance numbering, section/subsection numbers and any references thereto.

Section 7. Effective Date. This ordinance shall take effect on January 1, 2018 and be in force five (5) days after its passage, approval and publication.
