RESOLUTION NO. 2018-03

A RESOLUTION approving adjustment of the municipal Boundary line between the City of Ellensburg and Kittitas County, pursuant to RCW 35.13.340, as submitted by property owner Alex Galbraith for Parcel ID# 646733, 306 S. Willow Street, Ellensburg.

WHEREAS, RCW 35.13.340 authorizes the adjustment of the boundaries of cities and unincorporated areas of the county where part of a single parcel of land is located within the boundaries of the city, and the remainder of the parcel of land is located within the boundaries of the unincorporated county so that all of the parcel is located within either the city or the county, if the adjustment was requested in a petition signed by the property owner; and

WHEREAS, the owner of Kittitas County Tax Parcel No. 646733 has submitted a signed a petition calling for the adjustment of the municipal boundary line between the City of Ellensburg and Kittitas County; and

WHEREAS, RCW 35.13.340 authorizes the City to approve said petition for boundary line adjustment by resolution; and

WHEREAS, the City Council of the City of Ellensburg has determined that approving said petition and adjustment of the boundary line between the City of Ellensburg and Kittitas County pursuant to RCW 35.13.340 is in the best interests of the residents of the City of Ellensburg and will promote the general health, safety and welfare.

NOW, THEREFORE, the City Council for the City of Ellensburg do resolve as follows:

Section 1: The City Council of the City of Ellensburg resolves, pursuant to the provisions of RCW 35.13.340, to adjust the boundary line between the City of Ellensburg and Kittitas County so as to include within the corporate boundaries of the City of Ellensburg the remainder of the parcel of land depicted as Kittitas County Parcel ID # 646733, and more particularly described as

LOTS 9, 10, 11, 12, 13 and 14, BLOCK 12 Sunnyside Addition to Ellensburg, as per plat thereof recorded in Volume 1 of Plats , Page 25, Records of Kittitas County, State of Washington, except that portion of said Lot 14, lying within the right of way of Willow Street.

AND

The north half of Tacoma Avenue lying between the easterly right of way of Willow Street and the centerline of Cedar Street;

AND


The west half of Cedar Street between the northerly right of way of Tacoma Avenue and the centerline extended of the alley in Block 12, Sunnyside Addition to the City of Ellensburg, as per plat thereof recorded in Book 1 of Plats, Page 25, records of Kittitas County, Washington;

AND

The south half of the alley in Block 12, Sunnyside Addition to the City of Ellensburg, as per plat thereof recorded in Book 1 of Plats, Page 25, Records of Kittitas County, Washington, lying between the easterly right of way of Willow Street and westerly right of way of Cedar Street.

Section 2: This Resolution shall take effect immediately upon adoption, and a certified copy of the Resolution shall be filed with the offices of the Kittitas County Auditor and Assessor.
