

ORDINANCE NO. 4819

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ELLENSBURG, WASHINGTON, RELATING TO CHAPTER 1.30 OF THE ELLENSBURG CITY CODE ENTITLED "SALARIES AND BONDS" AND AMENDING SECTION 1.30.040 TO INCREASE THE MONTHLY COMPENSATION FOR THE OFFICES OF THE MAYOR AND THE CITY COUNCIL.

WHEREAS, Ellensburg Municipal Code Section 1.30.040 establishes the salaries to be paid to Ellensburg City Councilmembers; and

WHEREAS, the salaries paid to Ellensburg City Councilmembers have not been increased since 1995,

NOW, THEREFORE, the City Council of the City of Ellensburg, Washington do hereby ordain as follows:

Section 1. Section 1.30.040 of the Ellensburg City Code, as last amended by Section 1 of Ordinance 4559, is hereby amended to read as follows:

1.30.040 City council and mayor.


- A. Each person taking office as a member of the city council shall, from and after the commencement of the regular term of such council member position, receive as compensation \$250.00500.00 per month.
- B. In addition to his or her compensation as a member of the Ellensburg city council, the mayor shall receive compensation of \$250.00500.00 per month. [Ord. 4559 § 1, 2009; Ord. 3992 § 1, 1995; Ord. 3178 § 1, 1978; Ord. 2975 § 1, 1973; Ord. 2794 § 1, 1969; Ord. 2538 § 1, 1963.]

Section 2. Severability. If any portion of this ordinance is declared invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect the validity of the remaining portion(s) of this ordinance.

Section 3. Corrections. Upon the approval of the City Attorney, the City Clerk and the codifiers of this ordinance are authorized to make necessary corrections to this ordinance including, but not limited to, the correction of scrivener's/clerical errors, references, ordinance numbering, section/subsection numbers and any references thereto.

Section 4. Effective Date. This ordinance shall take effect and be in force five (5) days after its passage, approval and publication.


The foregoing ordinance was passed and adopted at a regular meeting of the City Council on the 7th day of January, 2019.
