

ORDINANCE NO. 4564

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ELLENSBURG, WASHINGTON RELATING TO ELLENSBURG MUNICIPAL CODE CHAPTER 8.54 "RESIDENTIAL PARKING ZONES"; AND AMENDING SECTION 8.54.999 BY ADOPTING A NEW MAP BY REFERENCE (EXHIBIT "A") WHICH REFLECTS THE REMOVAL OF THE NORTH SIDE OF 7TH AVENUE BETWEEN WALNUT STREET AND ANDERSON STREET FROM THE RESIDENTIAL PARKING ZONES AND AMENDING EXHIBIT "B."

WHEREAS, at its April 5, 2010 regular meeting the City Council approved a motion directing staff to prepare an ordinance excluding the north side of 7th Avenue between Walnut Street and Anderson Street from the residential parking zones,

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ELLENSBURG, WASHINGTON DO ORDAIN AS FOLLOWS:

Section 1. Section 8.54.999 of the Ellensburg Municipal Code, as last amended by Ordinance No. 4093 is hereby amended by the adoption of a new map, attached to the Code as Exhibit "A," which reflects the removal of the north side of 7th Avenue between Walnut Street and Anderson Street from the residential parking district.

Section 2. Exhibit "B" of Section 8.54.999 of the Ellensburg Municipal Code, as last amended by Ordinance No. 4093 is hereby amended to read as follows:

Exhibit "B"

All that area shown on the official map north of University Way shall have on-street parking restricted to vehicles containing RPZ permits, or signed service vehicles, during the hours of 8:00 a.m. to 5:00 p.m., Monday through and including Friday.

All that area shown on the official map south of University Way shall have on-street parking restricted to vehicles containing RPZ permits, or signed service vehicles, during the hours of 6:00 a.m. to 6:00 p.m., Monday through and including Friday, except for the north side of 7th Avenue between Walnut Street and Anderson Street which shall not be subject to residential parking zone restrictions. Section 3. Severability. If any portion of this ordinance is declared invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect the validity of the remaining portions of this ordinance.

Section 4. Effective Date. This ordinance shall take effect and be in full force five (5) days after its passage, approval and publication.

The foregoing ordinance was passed and adopted at a regular meeting of the City Council on July 6, 2010.



