Dear Senator Warnick:

We are respectfully seeking partial funding for the timely construction of a new Community Fieldhouse following the loss of the Ellensburg Racquet and Recreation Center. The City of Ellensburg is requesting \$1.5 million in community capital project funding necessary for the completion Phase II, Final Design and Permitting of the new Community Fieldhouse facility.

The fire incident on December 2, 2022, resulted in a total loss of the Ellensburg Racquet and Recreation Center, creating an immediate barrier to access public health facilities in Ellensburg and Kittitas County communities. In addition to being the hub for indoor fitness, the former facility served as a place for active social gathering and public health programming in our rural county. The loss of this facility creates an urgent need to address public health access in our community.

The City Council received messages and testimony from community members highlighting the importance of the former facility and the need to rebuild in a location accessible to the centralized population in Ellensburg. This project has extensive community support, as this facility will serve a diverse population, addressing health concerns and serve a community that experiences extreme climate conditions throughout the year. Additionally, we have provided letters of support from a broad cross-section of community partners, demonstrating the public value of this project.

The City, County, and community are working together to fund this facility. We intend to rebuild on City-owned land at Rotary Park, our existing outdoor sports complex. Improving upon the former facility, the new health and fitness center will be served by transit and will be energy efficient and ADA accessible to serve all community members.



The Kittitas County Public Health Department (KCPHD) supports the City of Ellensburg in their pursuit of creating infrastructure that promotes health and wellbeing within Kittitas County.

According to the most recent Community Health Assessment (CHA), Kittitas County residents have less access to exercise opportunities than the rest of the state. The Assessment also found consistent responses of frustration over the lack of activities for youth and families to participate in and focus group members expressed a new recreation center would improve access to opportunities for children and adults alike.

Major cardiovascular diseases have and continue to be the leading cause of death in Kittitas County. According to the Centers for Disease Control and Prevention, physical activity helps to reduce the risk of chronic disease, which includes major cardiovascular disease.


