The fire incident on December 2, 2022, resulted in a total loss of the Ellensburg Racquet and Recreation Center, creating an immediate barrier to public health access of the Ellensburg and Kittitas County communities. In addition to being the hub for a dynamic partnership between Central Washington University and the broader community for gymnastics and other recreational opportunities, the 40,000 square foot indoor facility served as a place for exercise and public health programming within an economically distressed rural Washington county. The Ellensburg Racquet and Recreation Center also served as a draw for prospective employees and their families to maintain an active and high-quality lifestyle as members of our region.
