The existing site is vacant building pad which was cleared & graded as part of the Lakeside Short Plat. The site currently covered with pasture grasses.

The site is generally flat with roadway ditches / infiltration swales along the west and east property lines.

Approximately 1% slope but 30% at the existing ditches.

The existing soils are classified as Brickmill Gravelly Ashy Loam, 0 to 2% slopes. These soils generally consists of gravelly sandy loam to 4 ft depth over gravelly loamy coarse sand.

- Peak hour volumes: Derived from observed counts at the Milton car wash facility. No formal traffic study was conducted for this site.
